

# **Voting Rights for Formerly Incarcerated People**

No updates required since August 9, 2024

#### Background

Every state has laws outlining who is eligible to vote, and almost all states restrict voting for those who are currently incarcerated for a felony offense—though a few states allow citizens to vote while incarcerated. States differ on when and how formerly incarcerated people can have their voting rights restored.

#### Scoring

- Voting rights are never lost or automatically restored upon release from incarceration, 1 point
- Rights lost until completion of sentence, including probation and parole, then automatically restored, ½ point
- Additional action is required post-sentence for restoration of rights, 0 points

• Additional action is required post-sentence for restoration of rights (<u>Ala. Code § 17-3-31</u>).

Alaska (1/2)

• Rights lost until completion of sentence, including probation and parole, then automatically restored (<u>Alaska Stat. § 15.05.030</u>).

Arizona (0)

 Additional action is required post-sentence for restoration of rights (<u>Ariz. Rev. Stat. §§ 16-101,</u> <u>13-907</u>; <u>Ariz. Const. art. VII, § 2</u>).



Arkansas (1/2)

• Rights lost until completion of sentence, including probation and parole, then automatically restored (<u>Ark. Const. amend. 51, § 11</u>).

California (1)

• Rights automatically restored upon release from incarceration (California Secretary of State).

Colorado (1)

• Rights automatically restored upon release from incarceration (<u>Colo. Rev. Stat. §§ 1-2-103</u>, <u>1-2-606</u>).

Connecticut (1)

• Rights automatically restored upon release from incarceration (<u>Conn. Gen. Stat. § 9-46a</u>). Delaware (0)

 Additional action is required post-sentence for restoration of rights (<u>Del. Const., art. 5, § 2</u>; <u>Del.</u> <u>Code tit. 15, § 6103</u>).

D.C. (1)

• Voting rights are never lost (<u>D.C. Act 23-336</u>: Comprehensive Policing and Justice Reform Second Emergency Amendment Act of 2020).

Florida (0)

• Additional action is required post-sentence for restoration of rights (<u>Fla. Stat. § 98.0751</u>). Georgia (1/2)

• Rights lost until completion of sentence, including probation and parole, then automatically restored (<u>Ga. Code Ann. § 21-2-216</u>).

Hawaii (1)

• Rights automatically restored upon release from incarceration (<u>Haw. Rev. Stat. § 831-2</u>). Idaho (1/2)

• Rights lost until completion of sentence, including probation and parole, then automatically restored (<u>Idaho Const. art. IV, § 3</u>; <u>Idaho Code § 34-201</u>).

Illinois (1)

• Rights automatically restored upon release from incarceration (<u>10 III. Comp. Stat. 5/3-5</u>). Indiana (1)

• Rights automatically restored upon release from incarceration (<u>Ind. Code § 3-7-46</u>). Iowa (1/2)

• Rights lost until completion of sentence, including probation and parole, then automatically restored (<u>Office of The Governor of Iowa</u>).



Kansas (1/2)

• Rights lost until completion of sentence, including probation and parole, then automatically restored (Kan. Stat. Ann. 21-6613).

Kentucky (0)

• Additional action is required post-sentence for restoration of rights (<u>Ky. Const. art. XII, § 145</u>). Louisiana (1/2)

• Rights lost until completion of sentence, including probation and parole, then automatically restored (La. Stat. Ann. § 18:102).

Maine (1)

• Voting rights are never lost (<u>Maine Secretary of State</u>).

Maryland (1)

Rights automatically restored upon release from incarceration (<u>Md. Code Ann., Elec. Law § 3-102</u>).

Massachusetts (1)

• Rights automatically restored upon release from incarceration (<u>Mass Gen. Laws Ch. 51, § 1</u> (2021); <u>Mass. Const., amend. III, amend. CXX</u>).

Michigan (1)

• Rights automatically restored upon release from incarceration (<u>Mich. Comp. Laws § 168.758b</u>). Minnesota (1)

- Rights automatically restored upon release from incarceration (MN HF 28 (2023)).
- Note, litigation brought in 2023 challenging the state's new rights restoration law was <u>rejected</u> by the Minnesota Supreme Court.

Mississippi (0)

 Additional action is require post-sentence before rights are restored (Miss. Const. art. 12, § 241).

Missouri (1/2)

• Rights lost until completion of sentence, including probation and parole, then automatically restored (Mo. Rev. Stat. § 115.133).

Montana (1)

• Rights automatically restored upon release from incarceration (<u>Mont. Const. article IV, § 2</u>). Nebraska (1/2)

• Rights are lost until completion of sentence, including probation and parole, then automatically restored (<u>Neb. Rev. Stat. § 32-313</u>).

Nevada (1)



Rights automatically restored upon release from incarceration (<u>Nev. Rev. Stat. §§ 176A.850</u>, <u>213.157</u>).

New Hampshire (1)

• Rights automatically restored upon release from incarceration (<u>N.H. Rev. Stat. Ann. § 607-A:2</u>). New Jersey (1)

• Rights automatically restored upon release from incarceration (<u>N.J. Stat. Ann. 19:4-1</u>). New Mexico (1)

• Rights automatically restored upon release from incarceration (<u>NM HB 4</u> (2023)). New York (1)

• Rights automatically restored upon release from incarceration (N.Y. Elec. Law § 5-106).

North Carolina (1)

 Rights lost until completion of sentence, including probation and parole. (North Carolina State Board of Elections)

North Dakota (1)

• Rights automatically restored upon release from incarceration (N.D. Cent. Code § 12.1-33-01).

Ohio (1)

• Rights automatically restored upon release from incarceration (<u>Ohio Rev. Code Ann. § 3503.21</u>). Oklahoma (1/2)

• Rights lost until completion of sentence, including probation and parole, then automatically restored (Okla. Stat. tit. 26, § 4-120.4).

Oregon (1)

• Rights automatically restored upon release from incarceration (<u>Or. Rev. Stat. § 254.470</u>). Pennsylvania (1)

 Rights automatically restored upon release from incarceration (<u>Pennsylvania Department of</u> <u>State</u>).

Rhode Island (1)

• Rights automatically restored upon release from incarceration (<u>17 R.I. Gen. Laws § 17-9.2-3</u>).

South Carolina (1/2)

• Rights lost until completion of sentence, including probation and parole, then automatically restored (S.C. Code Ann. § 7-5-120).

South Dakota (0)



 Additional action is required post-sentence for restoration of rights (<u>South Dakota Secretary of</u> <u>State</u>).

Tennessee (0)

• Additional action is required post-sentence for restoration of rights (<u>Tenn. Const. art. 1, § 5</u>). Texas (1/2)

• Rights lost until completion of sentence, including probation and parole, then automatically restored (<u>Tex. Elec. Code § 11.002</u>).

Utah (1)

• Rights automatically restored upon release from incarceration (<u>Utah Code Ann. § 20A-2-101.5</u>). Vermont (1)

• Voting rights are never lost (Vt. Const. Ch. II, § XLII).

Virginia (0)

• Additional action is required post-sentence for restoration of rights (<u>Va. Const. art. II, § I</u>). Washington (1)

• Rights automatically restored upon release from incarceration (Wash. Rev. Code § 29A.08.520).

West Virginia (1/2)

• Rights lost until completion of sentence, including probation and parole, then automatically restored (W. Va. Code §§ 3-1-3, 3-2-2).

Wisconsin (1/2)

• Rights lost until completion of sentence, including probation and parole, then automatically restored (<u>Wis. Stat. § 6.03</u>; <u>Wis. Stat. § 304.078</u>).

Wyoming (0)

• Additional action is required post-sentence for restoration of rights (Wyo. Stat. Ann. § 6-10-106).
