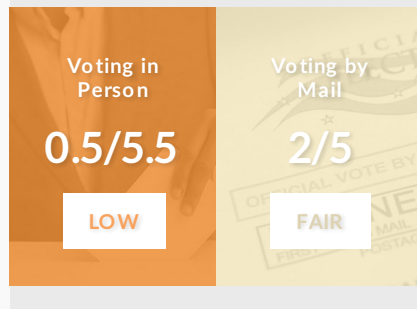
## Indiana's Democracy Tally



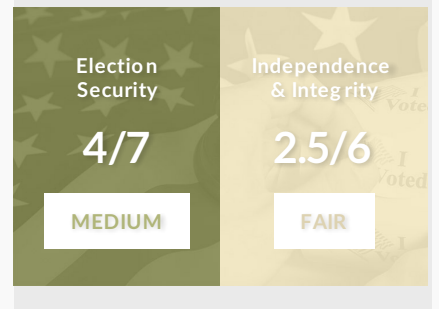
### Who Votes: 2.25/11
