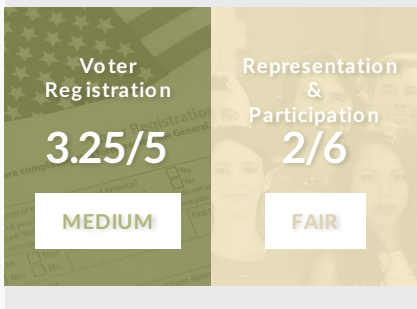

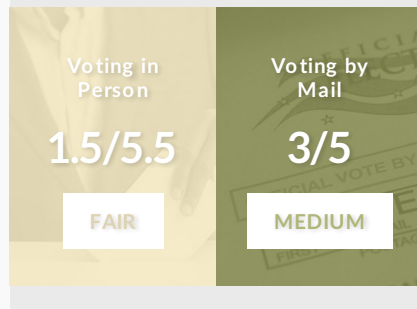
Pennsylvania's Democracy Tally



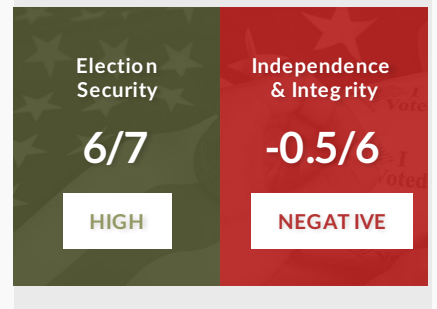
