Scores as of 09/12/2024

MAP's Equality Maps track over 50 LGBTQ-related state laws and policies. These laws are grouped into seven major categories: relationship and parental recognition; nondiscrimination; religious exemptions; LGBTQ youth; health care; criminal justice; and identity documents. These policies are scored across all 50 states, Washington DC, and the five U.S. territories, and these individual policy scores are then added together to create the Overall LGBTQ Policy Tally score. This Overall Tally helps illustrate a big picture view of the broader LGBTQ policy landscape across the country.
